### Boston Mills Ski Resort and Brandywine Ski Resort Event Participant Agreement and Release of Liability

Please read this carefully, this is a Release of Liability & Waiver of Legal Rights

1. I acknowledge that participation in the ski and snowboard competition described above, or training in connection with such event (collectively, the "Event") involve inherent danger and other risks of INJURY and DEATH! "Inherent dangers and risks of skiing" means those dangers or conditions which are an integral part of the sports of skiing, snowboarding or snowblading, including but not limited to snow conditions as they exist or may change, collisions with natural objects or man-made structures and their components; variations in steepness or terrain, whether natural or as a result of slope design, snowmaking or grooming operations, and collisions with other skiers, snowboarders or snowbladers. I voluntarily agree to expressly assume all risk associated with participation in or training for the Event, including without limitation, the risks and inherent dangers associated with skiing/snowboarding and riding the lifts. I understand that I have the opportunity to inspect the competition area prior to training for or participating in the Event and I assume the risk of all course conditions. Further, I understand that inverted aerials are not recommended.

2. In consideration of receiving permission to take part in the Event, I agree to defend, indemnify, release and hold harmless Boston Mills Ski Resort and Brandywine Ski Resort its affiliated companies, their respective agents, officers, directors, owners, contractors and employees (collectively, the "Released Parties") from any and all claims I might state as a result of physical injury, including death, or property damage sustained in connection with the Event, including those claims based on negligence. This release does not include claims resulting from intentional conduct by Boston Mills Ski Resort and Brandywine Ski Resort. I promise not to sue the Released Parties and further agree that if anyone is physically injured or property is damaged while I am engaged in this Event I will have no right to make a claim or file a lawsuit against the Released Parties. I agree to defend and indemnify the Released Parties for any and all claims, including subrogation and/or derivative claims brought by any third party or insurer, which I may cause. I understand that Boston Mills Ski Resort and Brandywine Ski resort are not responsible for the consequences of their own NEGLIGENCE, that is, their failure to use reasonable care in any way.

3. This release of liability supersedes any other agreements or representations by or between the parties and is governed by the provisions of the Ohio Revised Code and is intended to be interpreted as broadly as possible. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect.
